

The Archetype of Clauneck – Banker of Spirits, Financier of the Worthy

5. Symbolic Traits of His Archetype

2. What energetic *debts* or relationships am I still subsidizing?
3. Where do I fear loyalty—either giving it or asking for it?

These questions activate Clauneck’s mirror function. He will often begin responding once these inner dialogues are underway.

10. Assignment Before Next Lesson

Ritual Reflection Exercise

In a quiet space, speak aloud:

“Clauneck, show me where I have undersold my worth.”

Sit in stillness with his sigil. Write down the first image, word, or memory that arises. Do not rationalize—record everything. This will be used in Lesson 3.
